- Club Membership includes privileges beginning on the date of contract until formal termination by either party.
- Membership dues are non-refundable.
- Accounts over 30 days past due will be subject to a \$25 late fee each month until full balance has been paid. Accounts over 60 days past due will be suspended until the account is paid in full.
- Conduct detrimental to the use of the pool, golf course, other members, guests and/or staff may result in termination of membership. River Hills Golf Club reserves the right to revoke or deny any memberships at any time.
- Social Memberships include a Prime Times “Basic” Card. This card gives you discounted rates on all 21 Founders Group golf courses - including River Hills Golf Club. Other privileges of “Basic Card” include:
 - Special savings for up to 3 guests every time you play
 - Special 9-hole and afternoon rates.
 - Tee times may be booked with a 72 hours window online or 48 hours by calling
 - Signature Cardholder Events
- Use of the River Hills Golf Club pool is included with a Social Membership.
- Proper attire is required.
- Access to River Hill Member Events
- Social members receive a 20% discount on non-sale soft goods and 10% off non-sale hard goods in the Golf Shop.
- Social members receive a 20% discount in the grill (excluding alcohol, tobacco, special events, and daily specials.)

- Abide by all state and local laws and regulations, including the possession of any illegal drugs and weapons on any Founders Group International property.
- Consume alcoholic beverages in a legal and responsible manner, purchasing all alcohol at the facility. Privately-owned coolers are not permitted on the premises.

Please note that the privilege of any individual to utilize Founders Group International may be denied, suspended, or terminated if it is determined to be in the best interest of Founders. Any member or visitor who violates or fails to observe the Founders Group International Code of Conduct may be sanctioned as follows:

- Issuance of a verbal or written warning.
- Suspension of his/her playing privileges or membership for a defined period of time.
- Revocation of his/her membership without monetary reimbursement.
- Monetary restitution for damage to property.
